Under the Rules and Regulations of Bal Sadan, Board of Directors are not delegated any Financial powers to Utilize Foreign funds for providing medical or Nutrition aid to the families of inmate/ex-inmate of Bal Sadan. However It was resolved to utilize foreign funds Primarily to Mitigate the Suffering of our destitute children and their Families namely widowed destitute mothers and also to extend help to any genuinely needy child who may need the help of Bal Sadan Association at this Critical Juncture.
